Notice of Creation of a Trust - Blackwattle Series RMBS Trust No.6

Pursuant to clause 2.2(a)(1) of the Master Trust Deed dated 21 December 2012 between the Trustee and the Manager establishing the Sintex Trusts (the **Master Trust Deed**) (as amended from time to time) the Manager hereby gives notice of the creation of a Trust under the Master Trust Deed to be known as the "Blackwattle Series RMBS Trust No.6" (the **Trust**).

For the purpose of clause 2.6 of the Master Trust Deed this Notice of Creation of a Trust is accompanied by:



- (b) **(Residual Capital Units):**
 - (i) on behalf of Sintex Consolidated Pty Limited (a **Residual Capital Unitholder** and **Sintex**), \$9.00 in accordance with clauses 2.2(a)(2) and 4.3(a) of the Master Trust Deed and the Manager directs the Trustee to issue nine Residual Capital Units to Sintex in the Trust.
 - (ii) on behalf of CU Securitisation Services 3 Pty Ltd ACN 144 996 903 (a **Residual Capital Unitholder** and **CUSS**), \$1.00 in accordance with clauses 2.2(a)(2) and 4.3(a) of the Master Trust Deed and the Manager directs the Trustee to issue one Residual Capital Unit to CUSS in the Trust.

This Notice of Creation of a Trust is governed by the laws applying in New South Wales.

By signing this Notice of Creation of a Trust the Trustee acknowledges receipt of this Notice of Creation of a Trust from the Manager and the \$11.00 referred to above and agrees to its appointment as Trustee of the Trust in accordance with clause 2 of the Master Trust Deed.




